Contrary to popular belief, not all rescue dogs are "broken" or have a history of abuse or neglect. Many of them were once cherished pets and companions, but their families are no longer able to provide for their exercise needs. A perfect example of this is Winston, a healthy, 2 year-old male GSP. His family relocated from NC with a young infant in tow. The husband is working long hours at his new job, and the wife is left at home with a demanding childcare schedule, and no friends/family as a support system. She is not able to meet the exercise needs of a young GSP, so the family realized Winston was not enjoying the active life he so deserved. They have asked for our help in finding a loving home where he can enjoy daily exercise. Winston is wonderful with other dogs and children, and has a strong hunting instinct. He would likely be a lovely field companion or an agility prospect. He already knows all basic commands, and is eager to please. In 2010, Mid-Atlantic GSP Rescue established a "Midwest Chapter" to assist with the overwhelming number of GSPs in need in the states of OH, IN and KY. As an "arm" of Mid-Atlantic GSP Rescue, our group as a whole covers seven states (VA, MD, DE, WV, OH, KY, IN). In 2010, our chapter assisted 67 GSPs from our coverage area, with our group as a whole, assisting 132 GSPs. So far in 2011, we have assisted 79 GSPs from OH, KY and IN. The total for our entire group thus far in 2011 is 137. Because we are affiliated with a long established rescue in MD/VA, the dogs in our foster program receive more exposure to potential adopters. Their information and photos are available to adopters in seven states, which helps expedite the placement process. We find many adopters in the MD/VA/DE region are quite open to adopting "mature" GSPs, and have had no trouble placing GSPs as old as 13 years of age. This is an added bonus for our "mature" foster dogs, as their options for adoption are greatly increased with the added exposure.

Considering the incredible number of displaced GSPs in the region, we are always in need of breed experienced foster homes. Our rescue group covers ALL veterinary expenses, and we pay at the time of service, directly to the veterinarian providing the care. All GSPs are completely vetted, including all vaccinations, spay/neuter, heartworm test, fecal exams, microchip, etc. We spare no expense and do not turn away a GSP due to age. We are in desperate need for foster families. Often, just a temporary "safe" place is all we need until we can work out transport arrangements to an alternate foster location. Most shelters only give us a few days to remove the dog (due to their own space restrictions), so we must act quickly. A temporary foster home can truly mean the difference of life and death for a GSP in a shelter.

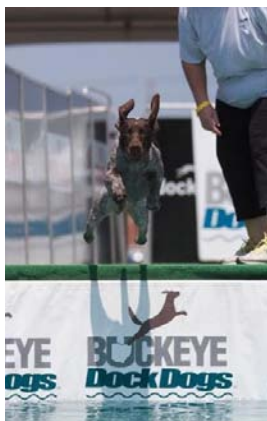
