Directions

From I-80 west:

Exit at Barkeyville, PA. Go south on PA 8 (Pittsburgh Rd., William Flynn Hwy) 0.7 miles, turn left onto PA 208 (Clintonville Rd.) go 2.5 miles, turn right onto Georgetown Rd. (street becomes Windy Point Rd) go 2.2 miles to 458 Windy Point Rd. and Club entrance.

From I-80 east:

I-80 to exit 35 (308 Clintonville, old exit 4). Go south on 308 towards Murrinsville-3.0 miles. Turn Rt. on Windy Point Road (no sign for Windy Point Rd. but sign on left side for SR I 005, blue trailer on Rt. Corner). Go 1.8 miles to 458 Windy Point Rd. and Club entrance.

From Route 8:

Route 8 to Harrisville, PA (approximately 5 miles south of I-80). Go right (east) on Hwy 58 (approx 7 miles) to Hwy 308 (W. Sunbury Rd). Turn left (north), go 6 to 7 tenths of a mile to Windy Point Rd. (no sign for Windy Point Rd. but sign on left side for SR I 005, blue trailer on Rt. Corner) turn left. Go 1.8 miles to 458 Windy Point Rd. and Club entrance.
