All tests will run a single course with a bird field. Quail will be used other game birds may be present.

PRIZES

Standard AKC Rosettes to all passing dogs. Special AKC Rosettes for dogs completing a title.

OPTIONAL EVENT ALLOWANCES

Tracking devices as specified by AKC rules and regulations will be permitted during these events.

IMPORTANT NOTICES REGARDING THE EVENT DAY

Please check in with the test secretary and line marshal upon arriving on the test grounds. Blaze Orange must be worn by all persons that enter the course or bird field during senior and master tests. The hunting test grounds will be the whole of Wayne Coon Hunter Club's property. All live fire will be supervised by the Captain of the Guns. To accurately report your qualification to the AKC, please notify the test secretary if you handled a dog that passed and were not listed as handler on the entry form.

IMPORTANT NOTICES REGARDING ENTRIES

Entries will close at 7:00 PM local time, Tuesday, May 06, 2014 with the test secretary at PO Box 106 Wooster, OH 44691. Drawing will take place at 6:00 PM local time, Wed. May 07, 2014 at 3768 Glenwood Rd Cleveland Heights, OH 44121.

Entries are limited to the number of dogs that can be run during daylight hours. Entries will close when this limit is reached. Entries received after limit has been reached will be placed on a waiting list according to postmarked date and the entrant will be notified.

Entry is open to all AKC pointing breeds six months of age on or before the test date that are part of an AKC registered litter or that have been individually registered with AKC or are an FSS registered breed. Bitches in season are not eligible to participate.

Entries must be on an official AKC Field Trial or Hunt Test entry forms and can be mailed or emailed. Checks for emailed entries must be received by the closing date and must have the dog's full name and registration number on the memo line as well as phone number or email address. Phone and fax entries will not be accepted. No entry shall specify any conditions as to its acceptance.

Incomplete entries do not constitute a valid entry and will be returned.

An entry form must be filled out for each dog and for each day entered regardless of whether they are mailed or emailed. It is not the secretary's responsibility to fill out or complete entries. Entries without correct fees, including returned checks do not constitute a valid entry and will be returned. Fees must be payable in U.S. funds. A \$25 service charge will be applied for each returned check.

Entry fees will not be refunded in the event that the dog is absent, disqualified or excused from competition by the action of the judges or the test committee.

Entry fees will be refunded for bitches in season if the test secretary receives such a request in writing before the dog is called to the line.

DIRECTIONS

From Cleveland: Take 77 South to exit 136 to OH-21S towards Massillon. Stay on 21 for 9.2 miles then exit onto OH-585 S towards Wooster. Stay on OH-585 S for 14.5 miles – Don't speed through Smithville- Turn left onto Summit Street which turns in to Eby Rd. After a little over a mile, take a slight right onto Canal Rd. Then take 2nd left onto N. Honeytown Rd, and a LEFT onto Secrest Rd. Club will be on your left.

From Columbus: Take 71N to exit 176 US 30 E towards Wooster for 26 miles. Take US 250E/ OH 83S exit towards New Philadelphia/ Millersberg, and keep LEFT at the fork; follow signs for East Lincoln Way. Turn RIGHT onto E. Lincoln Way/Pittsburgh Ave and continue on for 2 miles. Then turn RIGHT onto Honeytown Rd, and a LEFT onto Secrest Rd. Club will be on your left.
