
# HUNT TEST OAK RIDGE POINT DOG CLUB GROUNDS HARRISVILLE, PA MAY 6 & 7, 2017

# Ingredients

2 lbs. ground beef

1 medium onion, chopped

1 garlic clove, minced

2 cups tomato juice (or Spicy V8, if you want a little kick)

2-3 carrots, sliced

2-3 ribs celery, sliced

half a green pepper, chopped

10 oz. frozen corn

10 oz. frozen green beans

2 medium potatoes, cubed (or substitute with one cup of barley)

2 cups water (or if you want it extra beefy, use one cup water and one cup of beef broth)

1 tablespoon Worcestershire sauce

1/4 tsp. dried oregano

1/4 tsp. dried basil

1/4 tsp. dried thyme

dash of hot pepper sauce

2 tablespoons dry onion soup mix, or 1 beef bouillon cube

1 tsp. salt

1/4 tsp. pepper (Salt and pepper can be adjusted to taste. Feel free to add a little hot sauce, such as Tabasco, if you want it extra spicy.)

#### **Directions**

- (1) Brown meat and onions in saucepan. Drain. Stir in garlic and tomato juice. Heat to boiling.
- (2) Combine all ingredients in slow cooker.
- (3) Cover. Cook on Low 8-10 hours.

**<u>Variation:</u>** Use 1 c. barley in place of potatoes.



By now most of you know *Smitty* won the Amateur Limited Gun Dog event. With *Smitty* being diagnosed in October with bladder cancer, we were not quite sure he would make Brian's bucket list of participating in a Florida field trial. *Smitty* always gave 110% and he was not going to disappoint Brian.

The trial had a dog wagon where I watched Smitty run like the wind and "do everything by the textbook" (quoted



from FPGSP member Jim). With tears in my eyes, I watched *Smitty* get his two finds and a stop to flush. I held my breath that he would get around clean.

There were only three braces, six dogs. *Smitty* made it to the call backs. His competitor was a Vizsla named "Tango" (DC AFC Remek Valley Hunter Moon Dance SH) who was a bird-finding machine having as many as six finds. The gallery was filled with members, competitors, spectators and me. I watched with excitement as our *Smitty* did everything right. Tango was tough competition, but *Smitty* had the judge's favor. I could have not been more proud of this special dog who was an athlete, competitor and man's best friend during his final days.

*Smitty* managed to make a second check mark on Brian's bucket list by pointing a covey of quail at the Ames Plantation. Only the best get the opportunity and privilege to compete on these grounds and *Smitty* got the opportunity.

We were on the road two months traveling 4,400 miles. Not once did this dog complain. Every where we went he and *Heineken* made their presence known, bringing out stories from strangers about this unique breed of dogs.

*Smitty* crossed The Rainbow Bridge on April 10th, just three days after getting home. The paw print he left in my heart will forever remember this loving, gentle dog who gave us his all. RIP my *Smitty*.

# Charles R. Thornton - A Breed Pioneer

Dr. Charles R Thornton from Missoula, Montana his "Bredrite Kennels" His "every use" strains of breeding stock gradually became widespread in this country. All of his dogs were imported and from the basic and best bloodlines obtainable in Germany and Austria.

Dr. Charles Thornton traveled west in 1905 he was an ardent sportsman. Dr. Thornton was not only a breeder of fine German Shorthaired Pointers but he also was among the first to introduce Chinese and Hungarian pheasants to Western Montana. Dr. Thornton imported and bred German Shorthaired Pointers to hunt the wily pheasants. At one time, Dr. Thornton had more than 30 German Shorthaired Pointers in his kennels.


Although it is believed that the German Shorthaired Pointer may have existed in the United States long before the imports of Dr. Charles Thornton. Dr. Thorntons dogs were the first to be "officially documented" and registered with The American Field.

Dr. Thornton became interested in German Shorthaired Pointers after reading an article in a sporting magazine where he saw three pictures of Edward Rindt's German Shorthaired Pointers. Dr. Thornton decided he must have a couple of these all-purpose gun dogs. Dr. Thornton contacted Mr. Rindts and purchased a female by the name of Senta Hohenbruck and imported her into the United States. Senta was bred before arriving to the US. Dr. Thornton also purchased a male but he was killed the day of export.

Senta B Hohenbruck, arrived in the United States where she whelped 6 puppies from the sire, Treff v Hohenbruck. The pups were born on July 4, 1925. Senta and the 6 pups went on to produce the registered base stock of German Shorthaired Pointers in the U.S. Of the 6 American-whelped puppies. Dr. Thornton kept 3 pups as foundation stock and the rest were sold. Dr. Thornton greatly admired the Ger-

man Shorthaired Pointer and stated they were the greatest gun dog ever produced. Dr. Thornton believed that German Shorthaired Pointers should be winning in the field and on the bench. He supported Dual Champions. Dr. Thornton's dogs and breeding's soon became available through advertisement. Throughout the United States.





Many old Michigan kennel lines come from Thorton breeding's. Timm v Altenau as a sire, was one of those dogs. Timm v Altenau was purchased from Mr Charles Thornton by Mr. Hjalmar Olsen of Fieldborn Kennels. Timm was behind many of the Rheinberg dogs owned by Mr. William Erhler (Tim's second owner) Schnellberg Kennels had great success with Dual Champion Valdo v Schlesburg. Timm v Altenau was his great grand sire. Tim was also behind Sieglinde v Meihsen dam of the first BIS Ch. Sportsman's Dream. Timm was behind Dual Ch Nat'l Field Champion Dandy Jim Feldstrom and many great dogs and Kennels of Michigan.

Thornton breeding's embraced half-brothers and half-sister breedings to Reichs-und-Welt Sieger Heide vd Beeke: a three quarter brother to K.C. Bodo v.d. Radbach. the Prinz v Schlosshof inheritance of cleverness and sharpness the heavy leverage on the strain of Mars Altenau, Artus Sands and Edelmann Giftig. When in a pedigree there occurs a American-whelped Hohenbruck, Waldhausen, Brickwedde, or Altenau. Assume "Thornton Breeding"


