

Usage of tracking devices as specified by AKC rules and regulations will be permitted during these events. Tracking collars cannot have prongs. NO PRONG COLLARS OF ANY TYPE ALLOWED. No dog training permitted on the grounds.

AKC JUNIOR HANDLER PROGRAM

The German Shorthaired Pointer Club of Ohio encourages handlers ages 18 and under to participate in the American Kennel Club's[®] Junior Handler program. Please notify the test secretary at check in that a Junior Handler is handling as additional paperwork is required at the event.

IMPORTANT NOTICES REGARDING ENTRIES

- Entries will close at **7:00 PM**, local time, **Thursday April 3**, **2025 with the test** secretary at 120 Oakland Road Mercer Pa., 16137. The drawing will take place at **7:00 PM**, local time **Tuesday April 8**, **2025** at the same address.
- Entries are limited to the number of dogs that can be run during available day light hour and available birds. Entries will close when this limit is reached if this occurs prior to the specified closing time. Entries received after limit has been reached will be placed on a waiting list per postmarked date and the entrant will be notified of this.
- Entry is open to all AKC pointing breeds six months of age on or before the test date that are part of an AKC registered litter or that have been individually. registered with AKC or are an FSS registered breed. Bitches in season may be eligible to participate, if possible, to run at the end of the day.
- Entries must be on an official AKC Field Trial or Hunt Test entry form and must be <u>mailed with Checks and must be received before entries are consider valid.</u> Valid entries are excepted on first come bases. Phone entries will not be accepted. No entry shall specify any conditions as to its acceptance.
- Incomplete entries do not constitute a valid entry and will be returned.

An entry form must be filled out for each dog and for each test entered.

It is not the secretary's responsibility to fill out or complete entries.

- Entries without correct fees, or completed forms are not constitute a valid entry and will be returned. Fees must be payable in U.S. funds. A \$25 service charge will be applied for each returned check.
- Entry fees will not be refunded if the dog is absent, disqualified, or excused from competition by the action of the judges or the test committee.

BITCHES IN SEASON MAY BE PERMITTED TO RUN ONLY DURING THE LAST RUNS OF THE DAY AND MUST BE KEPT CONTAINED AND AWAY FROM FIELDS AND OTHER DOGS AT ALL OTHER TIMES.

Entry fees will be refunded for bitches in season if conditions do not permit running at the end of the day and Hunt Test Secretary is notified in advance.

- Please check in with the Test Sec. and Line Marshal upon arriving on the grounds.
 - It is especially important that you give them Vehicle information so we can find you and your dog when run time comes up.
- <u>An outer covering of blaze orange must be worn by all persons that enter the course or bird field during all tests, Junior, Senior and Master.</u> This includes those in the gallery near the Senior / Master field. All live fire on the hunt test grounds the entire day of the test must be supervised by the Captain of the Gun.
- Please notify the test secretary if you handled a dog that passed and were not listed as handler on the entry form to accurately credit you to AKC with your qualifications.
- Please dispose of dead birds, dog waste and your trash appropriately.

If you are coming from the East or I-79 go to Cranberry, PA get on Rt. 19 go to Rochester Road. Take Rochecter Road West about 4-3/4 miles to Rt. 989, Rt 989 north just .2 of a mile to Big Knob Road, Big Knob road 1-3/4 miles to Bonzo Road on the right, Take Bonzo to Club grounds about 3/4 of a mile on left.

If you are coming from the west or I-376 go to Rochester, PA get on rt. 68 go east through Rochester. Take Rt .68 about 9 miles to Big Knob Road, Rt. 68 turns to the left here Big Knob Road is straight ahead. At Big Knob Road 1.5 miles to Bonzo road on the left, Take Bonzo Road to Club grounds about 3/4 of a mile on left.
