Take Rochester Road West about 4-3/4 miles to Rt. 989, Rt 989 north just .2 of a mile to Big Knob Road, Big Knob Road 1-3/4 miles to Bonzo Road on the right, Take Bonzo to Club grounds about 3/4 of a mile on left.

If you are coming from the west or I-376 go to Rochester, PA get on rt. 68 go east through Rochester. Take Rt .68 about 9 miles to Big Knob Road, Rt. 68 turns to the left here Big Knob Road is straight ahead. At Big Knob Road 1.5 miles to Bonzo Road on the left, Take Bonzo Road to Club grounds about 3/4 of a mile on left.
